Austin Weekly Deal Highlights

Good news hits so much harder these days, and boy am I excited for the team at **Homeward** who just pulled in \$105M in financing! I am most likely not just saying that because they are one of our portfolio companies, and more so because they are significantly simplifying the frustrating home buying and selling process. And icing on the cake, proud to announce our recent investment in **ConverseNow**, what an addition to the portfolio and what a week! Hope all of my people out there are finding their happiness!

Austin Financing Activity

- **Homeward**, a comprehensive home buying and selling platform to enable consumers to buy their next home prior to selling the one they have, raised \$105M in financing, which is comprised of \$20 million in new equity funding and an additional \$85 million in debt to help finance home transactions. The equity portion of the deal was led by **Adams Street Partners**, with additional funding from **Javelin Venture Partners** and existing investor **LiveOak Venture Partners**.
- **NextGen Venture Partners**, an Austin, Texas-based early-stage VC firm, raised \$52 million for its second fund.
- **ConverseNow**, a communication platform designed to automate and personalize restaurant orders, raised \$3.25M in seed funding. The round was led by **Bala Investments**, with participation from investors **LiveOak Venture Partners**, **Tensility Venture Partners**, **Knoll Ventures**, **2048 Ventures**, **Bridge Investments**, and **Ken Neeld**, CEO of **Delphi Display Systems**.
- **Altr**, a data security and privacy company, has raised \$15M in new funding from Ronin Capital CEO John Stafford III, Kevin Gainer, Roger Farley and several other angel investors. This group of investors previously led their \$15M round in 2018.
- **Kronologic**, a calendar automation platform, just capped off a new round of funding, closing a \$3.5 million seed round. The investment was led by **Silverton Partners**, with participation from **Next Coast Ventures** and **Geekdom Fund**.
- **Carestarter Technologies**, a healthcare management platform, has raised \$1.4M in equity funding. The target for the round is \$2.3M.
- **Localeur**, a travel recommendations platform, has raised \$127K in equity funding. The company also has content partnerships with **Match Group** and **Jet Blue**
- **AppClose**, a co-parenting app to make child care management easier, reported raising \$2M in new equity funding. This is after a \$500K equity funding in October.

Austin M&A

- **Superpowered**, a mobile-based audio application designed to create and process custom music files for game, was acquired by music tech platform **Splice** for an undisclosed amount.

Other Regional Activity

- **Liongard**, a Houston-based unified automation platform for managed service providers, raised \$17 million in Series B funding. Updata Partners led, and was joined by TDF Ventures and Integr8ted Capital.
- **Fitz Gate Ventures**, which operates out of Houston but with the support of Princeton University, raises second flagship venture capital fund at \$15M, according to Pitchbook.

- [Saranas](#), a Houston-based developer of a medtech device designed to improve patient outcomes through early detection of internal bleeding complications, raised \$1.65M of venture funding in the form of convertible debt from undisclosed investors. The company has raised over \$14M to date.

- [Catapult Systems](#), an IT services firm with ties to Microsoft, has [promoted](#) [Terri Burmeister](#), to the president. She has worked for the company for 13 years, rising through the leadership ranks as Florida general manager, vice president of sales, and most recently, president of U.S. Operations. Before joining Catapult, she worked for 14 years at [Software Architects](#), which was acquired by [Sogeti](#).
- [Revionics](#), a provider of retail pricing, promotions, markdowns, and advanced analytics solutions, [announced](#) the hiring of [Joshua Oettle](#) as principal product and program manager. Oettle was also senior program manager and senior product manager at [RetailMeNot](#).
- [Magnitude Software](#), a data management and business solutions platform, is [hiring](#) an additional 200 members to its 100 person Austin team. This will happen roughly over the course of the next year or so. These hires come after the company has reportedly tripled profit and revenue over the past 3 years.
