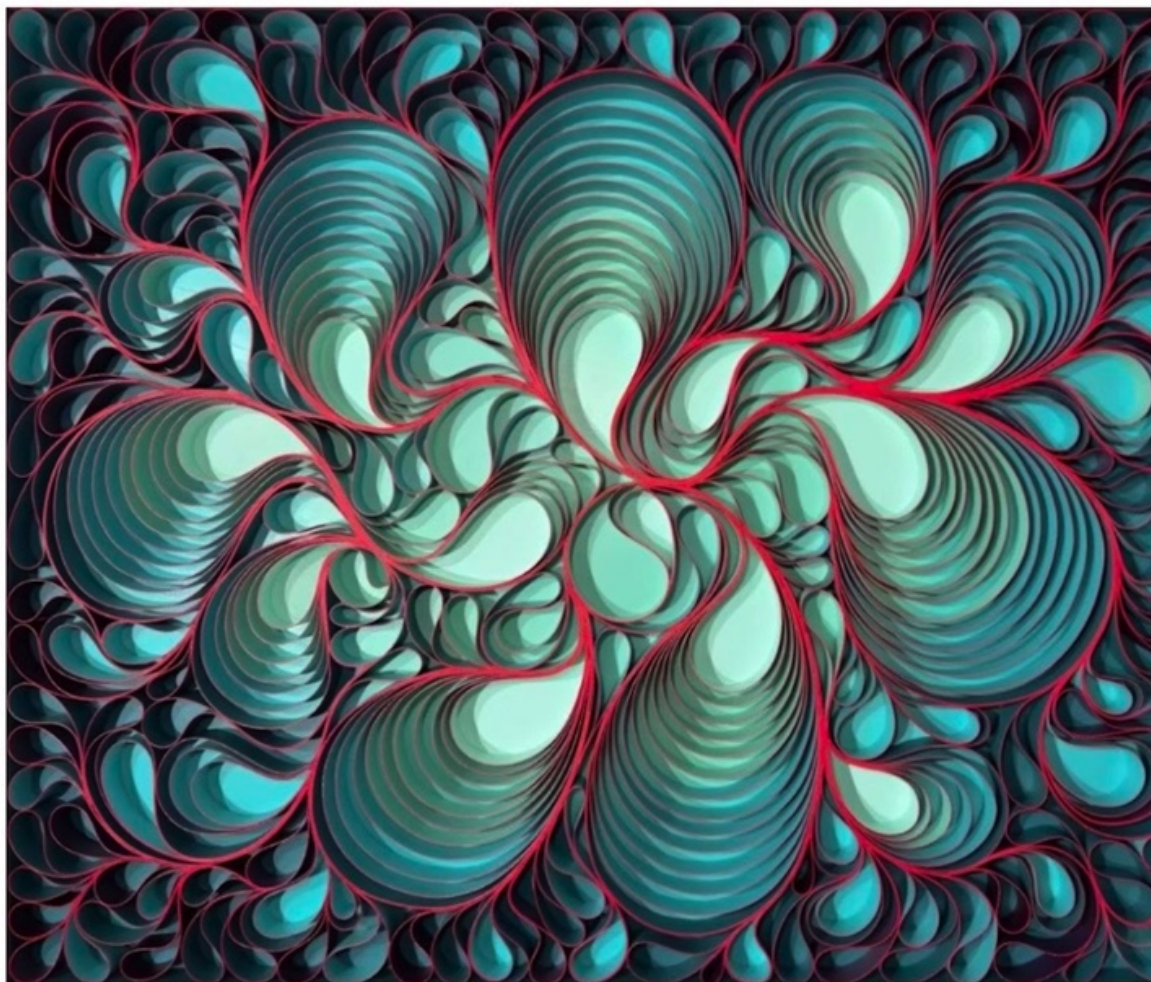
Austin Weekly Deal Highlights

I know we were once all too familiar with a feat like this, but it's not 2021 anymore, so let's take the W! Plus, here's [Forbes 30 Under 30](#) for Austin, to help ensure we keep the dice rolling. And for context on our bright spot of fundraising locally, [here's a look](#) at how startup valuations fared in Q2 across the country – spoiler alert, we're still in a correction.

Austin Deal Activity

- [One Model](#), a provider of HR analytics software, [raised \\$41m](#) led by **Riverwood Capital**. The company has raised approx. \$58M to date from investors including **Geekdom Fund**, **AV8 Ventures** and **QIC**.
- [Osano](#), a data privacy management startup, raised [\\$25m in Series B funding](#). **Baird Capital** led, and was joined by **Jump Capital**, **LiveOak**, **NextCoast** and **TDF**. The company has raised approx. \$44M to date.
- [Flueid](#), a company using data and intelligence to accelerate the Verification of Title (VOT) across the real estate life cycle, [raised \\$12.5M](#), which includes a \$10M Series B1 raise and \$2.5M in debt financing from Eastward Capital Partners. The B1 round was led by **Aquiline Technology Growth (ATG)** and included participation from **Commerce Ventures**, both of which contributed to its Series A and Series B. It adds to its [\\$20M raise announced in October 2022](#).
- [Flo Recruit](#), legal recruitment software unlocking data-driven strategy for law firms, announced that it has closed an oversubscribed [\\$4.2M seed round](#) led by **LiveOak Venture Partners** and **Moneta Ventures** with participation from **Tau Ventures** and **Alumni Ventures**.
- [Homemade](#), a real estate flipping platform [raised \\$4m seed round](#) led by **Signia Venture Partners**. **Shrug Capital**, **Night Ventures** and **Kyber Knight Capital** also participated in the round.
- [Accelsius](#), a company developing thermal technology to cool data centers, [raised \\$2m](#) of venture funding in the form of convertible notes from undisclosed investors. The company has raised approx. \$8M to date.
- [SnapAds](#), a local community marketing platform, raised \$1.2M of pre-seed funding led by **User Friendly Holdings**.
- **Wrap Technologies** [acquired Intrensic](#), an Austin-based digital evidence management and body worn cameras company. Financial terms were not disclosed.
