Austin Financing Activity

- <u>Nutrabolt</u>, the company behind energy drinks such as C4 and Xtend, <u>received an \$863M</u>
 <u>investment</u> from **Keurig Dr Pepper** for a 30% stake. The deal puts the value of Nutrabolt at \$2.87B. Nutrabolt is expected to post 2023 sales of at least \$650M.
- <u>Setpoint</u>, the company building infrastructure for modern real estate transactions, closed a <u>\$43M Series A</u> led by Andreessen Horowitz with participation from <u>LiveOak Venture Partners</u>,
 <u>Stonecroft</u>, <u>75andSunny</u>, <u>Fifth Wall</u>, <u>645 Ventures</u>, <u>NextView Ventures</u>, <u>Vesta Ventures</u>, and <u>ATX Venture Partners</u>. The raise comes just six months after Austin, Texas-based Setpoint closed a \$5.5M seed round and \$150 M in securitization.
- Maergo, an e-commerce shipping and logistic platform, <u>raised \$20M of seed funding</u> led by Neel Shah, ACR Alpine Capital Research and Deep Lake Capital Acquisition
- MOON Ultra, a selfie lighting device designed to illuminate photos and videos, raised a \$15M
 Series B funding from GRAMMY Award-winning producer L.A. Reid and GRAMMY Award-winning artist Burna Boy among more than 20 additional sports and entertainment stars.
- MALK Organics, a producer of milk alternatives, raised a \$9M Series B led by Rotor Capital Partners and Benvolio Group. The company has raised approx. \$17M to date.
- <u>Protopia AI</u>, a company that helps enterprises leverage their AI data, raised <u>\$6M in Seed funding</u> led by **ATX Venture Partners** with participation from **Galaxy Interactive**, **Silverton Partners** and

DNX Ventures.

- Hopstack, a warehouse management and execution platform, <u>raised \$2.8M</u> for seed funding from Sente Ventures and other undisclosed investors.
- Ribbon, a platform to simplify the process to obtain nonprofit status, <u>raised \$2.7M Seed Round</u> led by **Trust Ventures**.

Other Texas Deal Activity

- Sportsmap Tech Acquisition (Nasdaq: SMAP), a Houston-based special purpose acquisition
 company led by some prominent names in media and sports has <u>reached a deal</u> to take
 Beaumont-based Infrared Cameras Holdings public. The company provides thermal imaging
 platforms, and the deal is expected to close in the first half of 2023.
- <u>Training All People</u>, a Plano-based training company intended to provide vocational skills to people in need, raised \$4M of seed funding from **8VC** and other undisclosed investors, per Pitchbook.
- <u>RETINA-AI</u>, Houston-based software provider that uses AI to diagnose diseases such as diabetic retinopathy from pictures of the retina, <u>raised \$2.5M</u> of venture funding in the form of SAFE notes from undisclosed investors
