In 2022 <u>VW FWD</u>, a <u>Vela Wood</u> initiative, donated \$57,000 to causes that support justice and equal rights for marginalized communities as part of our pledge to donate \$500,000 over ten years. Austin Financing Activity

- <u>8fig</u>, a fintech platform who provides small- to medium-sized e-commerce businesses with financial tools to help them achieve sustainable growth, <u>raised a \$140M Series B</u> round led by **Koch Disruptive Technologies**. Its latest funding round brings its total venture capital raised to \$196.5M to date.
- <u>Babylon</u> v(NYSE: BBLN), an Austin, Texas-based provider of value-based health care,<u>agreed to go private</u> via a restructuring led by AlbaCore Capital.
- <u>Noveon</u>, developer of magnet-to-magnet recycling system, raised \$150M of venture funding from **NGP** and other undisclosed investors. The company has raised approx. \$213M to date.
- <u>Vida Global</u>, a communication platform for direct conversations with private messaging and calling, <u>raised \$2.5M</u> of venture funding from undisclosed investors. Previously, the company raised an undisclosed amount of venture funding from Lightning Ventures in November 2022

Other Texas Deal Activity

- Houston-based Mattress Firm Group Inc. is <u>being sold again in another</u> <u>multibillion-dollar</u>. Lexington, Kentucky-based Tempur Sealy International Inc. (NYSE: TPX) will acquire Mattress Firm in a cash-and-stock deal valued at approximately \$4B.
- <u>Netwrix</u>, a Frisco-based visibility and governance for threat detection, <u>entered into a definitive agreement</u> to receive an undisclosed amount of development capital from **Centerbridge Partners**. **TA Associates** (TA), a leading global private equity firm, remains the majority shareholder, with members of Netwrix's senior management team and **Updata Partners** retaining minority positions in the business.
- <u>Car Capital</u>, a Grapevine,TX-based provider of a unique financing program for auto dealers, announced an <u>\$8.8M Series C</u>, \$50M in debt, and its

relaunch into the Midwest and Southeast and expansion to Western states.

- Austin startup accelerator Newchip <u>collapses amid bankruptcy case</u>, takeover attempt
- E-discovery platform **Disco** <u>laid off 8% of its workforce</u> for its second round of layoffs in 2023. The venture backed company went public in 2021, and has a market cap of approx. \$353M as of closed of business Friday.
- EV supplier **CelLink** in line for <u>\$362M federal loan</u>v ahead of Georgetown factory opening
- 86 finalists in running for Austin Under 40 Awards
- ACL Music Festival's economic impact climbs 21%, to \$447.9M
